1. Call to Order

The meeting of the Arizona Board of Behavioral Health Examiners was called to order on July 12, 2013, at 8:00 a.m. with Mr. Lankton presiding.

3. Applications for licensure: review, consideration and action

Social Work

Mr. Lankton moved, seconded by Dr. Gabler, to approve 6 applicants as Licensed Clinical Social Workers and 22 applicants as Licensed Master Social Workers. The motion passed unanimously.

Dr. Bowden moved, seconded by Ms. Coonrod, to deny 2 applications based on a finding of unprofessional conduct. The motion passed unanimously.

Dr. Gabler moved, seconded by Ms. Coonrod, to approve 5 applicants as Licensed Marriage and Family Therapists. The motion passed unanimously.
