1. Call to Order

The meeting of the Arizona Board of Behavioral Health Examiners was called to order on March 10, 2013, at 9:01 a.m. with Mr. Lankton presiding.

2. Roll Call

3. Applications for licensure: review, consideration and action

Social Work

Mr. Lankton moved, seconded by Dr. Bowden, to approve 7 applicants as Licensed Clinical Social Workers, 3 applicants as Licensed Clinical Social Workers by endorsement, 22 applicants as Licensed Master Social Workers and one applicant as a Licensed Bachelor Social Worker. The motion passed unanimously.

Mr. Lankton moved, seconded by Dr. Bowden, to deny one application based on failure to take the required exam and one application based on failure to pass the required exam. The motion passed unanimously.

Counseling

Dr. Bowden moved, seconded by Ms. Coonrod, to approve 21 applicants as Licensed Associate Counselors, 6 applicants as Licensed Professional Counselors and 7 applicants as Licensed Professional Counselors by endorsement. The motion passed unanimously.

Dr. Bowden moved, seconded by Dr. Gabler, to deny 4 applications based failure to meet minimum requirements. The motion passed unanimously.

Substance Abuse

Dr. Bowden moved, seconded by Ms. Coonrod, to approve 3 applicants as Licensed Associate Substance Abuse Counselors. The motion passed unanimously.

Dr. Bowden moved, seconded by Mr. Lankton, to deny 3 applications based on failure to meet minimum requirements. The motion passed unanimously.

A. Appointment of member(s) to the Rules Subcommittee

Ms. Zavala provided information regarding professionals who are interested in the vacancies on the Rules Subcommittee and the Board's responsibility to appoint members.

Following discussion, Dr. Gabler moved, seconded by Dr. Bowden, to appoint Shiloh Lundahl, Laura Masters and Del Worley to the Rules Subcommittee. The motion passed unanimously.

Following discussion, Ms. Coonrod moved, seconded by Ms. Shields, to set the Interim Executive Director's salary as requested and retroactive to February 6, 2014. The motion passed unanimously.
