B. Update on HB2065

Ms. Zavala shared that the Bill was not heard and that she was told that the monies would be reallocated back into the Board's account during the budget approval for the state.

C. Update on HB2569

Ms. Zavala informed members that HB2569 was signed by the Governor on April 10, 2019 and will go into effect 90 days after the legislative session adjourns. The Bill is another pathway for out of state applicants to get licensed in Arizona. It will require a license in the same discipline and at the same level

from a regulating entity for at least one year. It will also require that applicants have a license in good standing and are residents of Arizona.

D. Review, consideration and possible action regarding the August meeting date

Ms. Zavala notified members of a conflict with the August 9, 2019 Board meeting and the NBCC national conference.

Following review and discussion by members, Mr. Coffey moved, seconded by Ms. Shields, to change the August meeting date to August 16, 2019. The motion passed unanimously.

E. Review, consideration and possible action regarding the substantive policy statement #2017-01 regarding supervision acquired in another state by an applicant for Arizona licensure

Ms. Dalton informed members that with the rulemaking effective January 12, 2019, Substantive Policy Statement 2017-01 is no longer needed.

Following review and discussion by members, Dr. Davis moved, seconded by Ms. Shields, to repeal Substantive Policy Statement 2017-01. The motion passed unanimously.

F. Review, consideration and possible action regarding R4-6-211 and temporary licenses

Ms. Dalton informed members that A.A.C. R4-6-211 allows masters level licensees subject to direct supervision to engage in supervised private practice, including temporary licensees. Ms. Dalton shared concern from the professional associations that temporary licensees who have recently graduated and are waiting to take their national exam could engage in supervised private practice, which would be problematic should they fail the exam and their temporary license expires.

Following review and discussion by members, Ms. Shields moved, seconded by Mr. Barnett, that supervised private practice pursuant to A.A.C. R4-6-211 is not deemed an appropriate practice setting for temporary licensees qualifying under A.A.C. R4-6-306(A)(3)(b). The motion passed unanimously.

G. Review, consideration and possible action regarding A.R.S. § 32-3274 licensure by endorsement

Ms. Dalton informed members that applications for non-independent licensure by endorsement are not reviewed for meeting curriculum requirements pursuant to A.R.S. § 32-3274. When those licensees apply for independent licensure by examination, the applications will be reviewed for meeting the curriculum requirements.

Following review and discussion by members, Mr. Szymanski moved, seconded by Dr. Davis, to review the education to ensure that they meet educational qualifications. The motion passed unanimously.

H. Update on governor appointments

Ms. Zavala informed members that committee members for each of the academic review committees have received appointments. All four committees have two members which leaves one vacancy that still needs to be filled. Additionally, Ms. Quinlan was reappointed to the Board and two more public members have been appointed.

I. Update on the conference for the Association of Social Work Boards

Dr. Davis updated members on the ASWB national conference recently attended by he and Ms. Zavala. He shared that the key topics were license portability and criminal background checks.

J. Update on Phoenix Seminary and ASU presentations

Ms. Zavala updated members on recent presentations done by Board staff at Phoenix Seminary and Arizona State University.

K. Review, consideration and possible action regarding MFT designee appointment

Ms. Zavala informed members that with Mr. Barnett's resignation from the Board, a new MFT designee would need to be appointed.

Following review and discussion by members, Mr. Barnett moved, seconded by Dr. Davis, to appoint

Ms. Bailey as the MFT designee. The motion passed unanimously.
