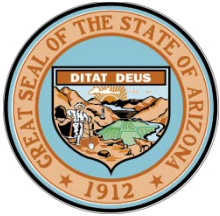


## NOTICE OF ORAL PROCEEDING
